

**Floyd County Electoral Board**  
**MINUTES**  
**Provisional Canvass and Canvass 13 June 2018**

**Provisional Canvass**

Convened at 10:30 a.m. In attendance, Brecc Avellar, Vice Chair, Bob Smith, Chair, Amy Ingram, GR, Steven Wood, Rhonda Vaughn, Clerk of Court, Chief Officer of Elections, Precinct 501 and John Hopkins, Observer.

Quorum being present, Motion by B. Avellar to nominate Bob Smith to serve as Acting Secretary, 2nd by Smith and motion carried.

Board examined outside envelope of Provisional Ballot cast on 12 June, all information present and signatures present, outer envelope found to be in legal compliance.

Meeting was adjourned briefly by acclamation after preliminary examination for discussion of available options. Re-convened at 10:33 with the examination and opening of the inner Provisional envelope. It was determined to be in compliance. A. Ingram, GR advised that it was permissible to have the voter submit ID via electronic communication, or, to come to the Office and have a Temporary Voter ID created with acceptable ID provided. B. Avellar called to inquire as to whether the voter had ability to send in verification. Voter was not able to submit via email or fax, but offered to come to the Registrar's Office to have a Temporary Voter ID created during his lunch break.

Meeting was adjourned by acclamation at 10:45 to begin process of staging the Conference Room in the Sheriff's Office.

Meeting Re-convened at 11:15 when Voter arrived. A. Ingram, GR verified voter was eligible, obtained a signed copy of Affirmation of Eligibility and created the Temporary Voter ID Form in duplicate.

**Canvass**

Meeting convened at 11:25 a.m. In attendance were Brecc Avellar, Vice Chair, Bob Smith, Chair, Amy Ingram, GR, Joan Slusher representing, Clerk of Court, Tammy Belinsky, Secretary (by phone) and John Hopkins, Observer.

T. Belinsky moved to go into Executive Session, 2nd by B. Smith, motion carried. Observer left the conference room. A. Ingram confirmed eligibility of Provisional Voter, and presented copy of Temporary ID to be attached to Envelope 2 for Precinct 201, Republican Primary. Upon examination of the Ballot, it was determined that the vote had been cast for Republican Candidate Stewart. B. Avellar signed inner envelope. B. Smith signed outer envelope.

Executive Session terminated by acclamation on motion by B. Avellar, 2nd by B. Smith at 11:30, all present, Observer returned to conference room.
